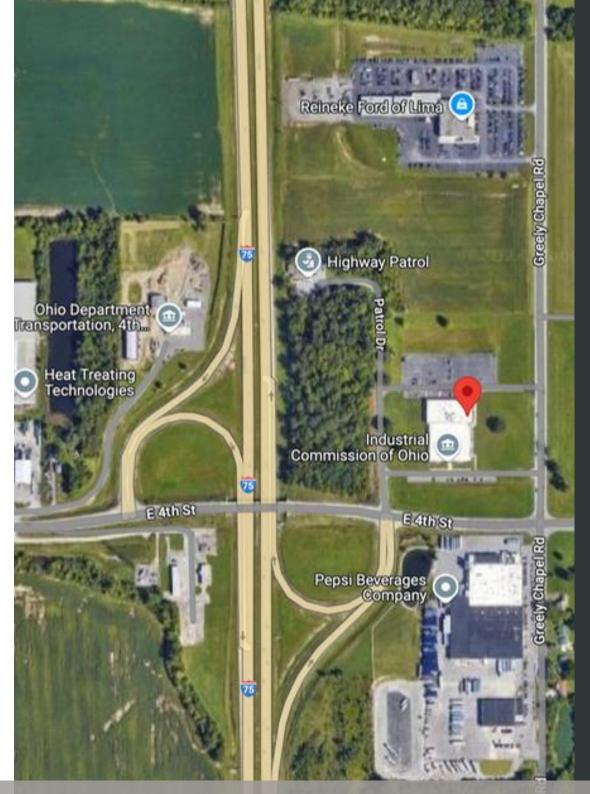
AREA OVERVIEW

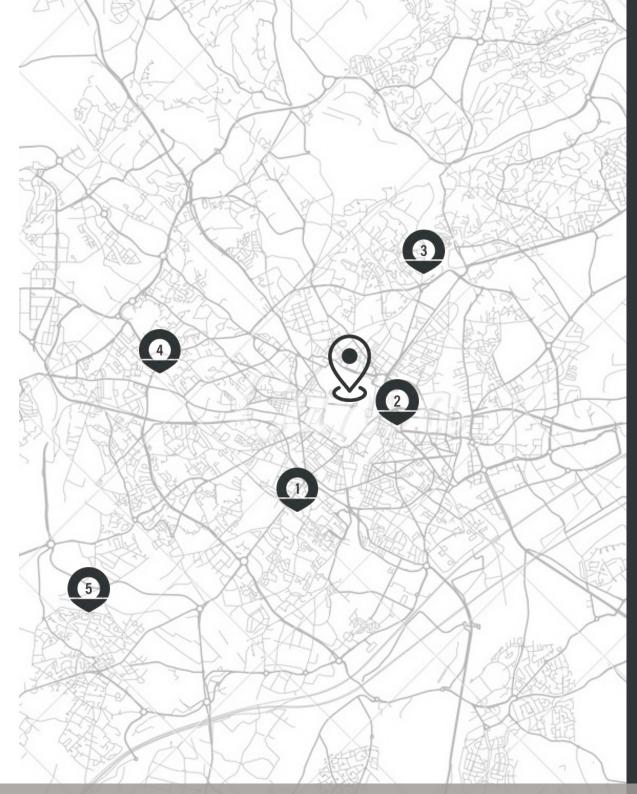

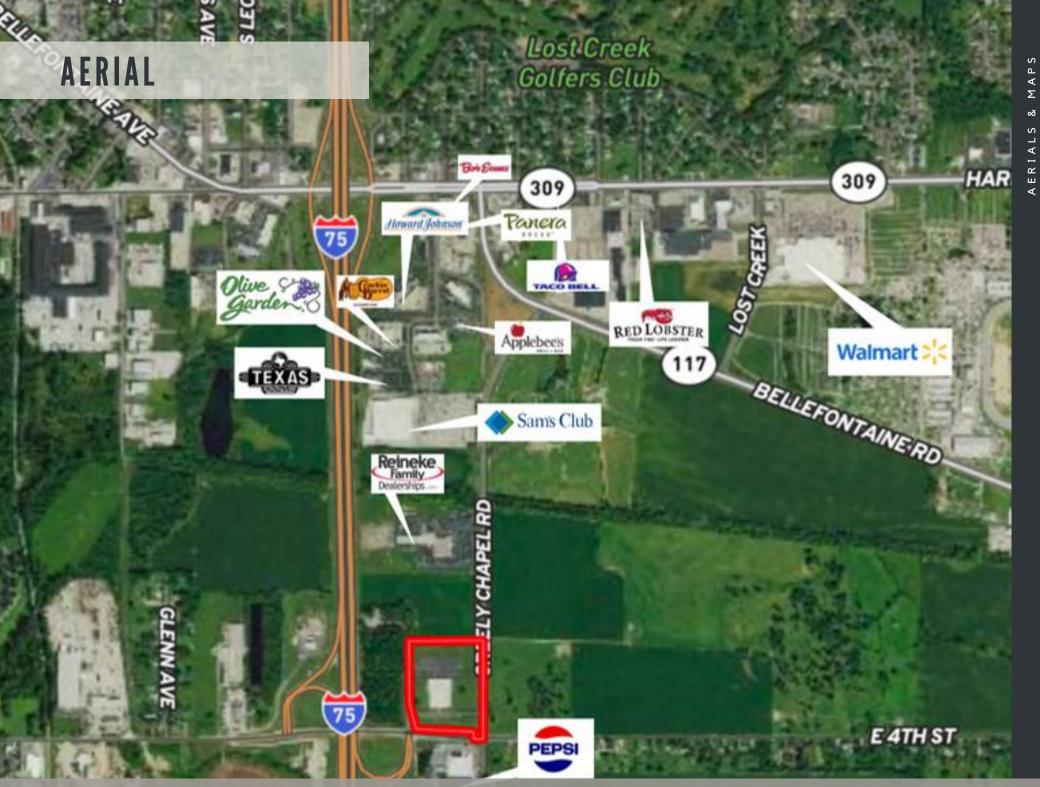
