



Description for 40.499 Acres

Situated in the Southeast Quarter of Section 19, Town 2 North, Range 14 East, Hopewell

Township, Seneca County, Ohio, being all of the southeast quarter of the southeast quarter as described in deed recorded in Official Record Volume 362,

Page 3084 and being more particularly described as follows;

Beginning at the southeast corner of the southeast quarter said Section 19, being a 5/8" iron

pin found;

Thence on the south line of said southeast quarter, N.89°01'49"W., a distance of 1328.50

feet to a mag set;

Thence on the west line of said southeast quarter of the southeast quarter, N.00°53'31"E.,

a distance of 1326.74 feet to a 5/8" iron pin set at the northwest corner of said southeast quarter of the southeast quarter, passing a 5/8" iron pin set at 20.00 feet;

Thence on the north line of said southeast quarter of the southeast quarter, S.89°08'48"E.,

a distance of 1328.14 feet to a mag nail set at the northeast corner of said

southeast quarter of the southeast quarter, passing a wood post found at 1298.76

feet;

Thence along the east line of the southeast quarter of said Section 19, also being the

centerline of County Road 18, S.00°52'35"W., a distance of 1329.43 feet to the

Principal Point of Beginning;

Containing 40.499 acres, more or less, of which 1.211 acres lie in road right of way and being

subject to all legal highways, rights-of-way, easements, restrictions, covenants,

and/or conditions of record.

Description for 63.301 Acres

Situated in the Northeast Quarter of Section 30, Town 2 North, Range 14 East, Hopewell

Township, Seneca County, Ohio, being part of the east half of the northeast quarter as described in deed recorded in Official Record Volume 451, Page 1609 and being more

particularly described as follows;

Commencing at the southeast corner of the northeast quarter said Section 30, being a mag nail found;

Thence along the south line of the northeast quarter of said Section 30, N.88°48'34"W., a

distance of 410.00 feet to a 5/8" iron pin found, being the Principal Point of Beginning;

Thence continuing along said south line, N.88°48'34"W., a distance of 915.17 feet to a 5/8" iron

pin set at the southwest corner of the east half of said northeast quarter of said Section

30;

Thence on the west line of said east half, N.00°57'44"E., a distance of 2158.45 feet to a 5/8" iron

pin set;

Thence on a new division line, S.89°01'49"E., a distance of 1327.88 feet to a mag nail set in the

east line of said northeast quarter, also being the centerline of Couty Road 7, passing a

5/8" iron pin set at 1307.88 feet;

Thence on said east line, S.01°02'03"W., a distance of 1896.60 feet to a mag nail found at the

northeast corner of a 2.507 acre tract as describe n Official Record Volume 451, Page

3293;

Thence running along a said 2.507 acre tract on the following two (2) courses and distances:

1. N.88°58'20"W., a distance of 410.00 feet to a 5/8" iron pin found, passing a 5/8" iron

pin found at 20.00 feet;

2. S.01°02'03"W., a distance of 265.79 feet to the Point of Beginning
