#### Purpose of Request:

Approve the Intergovernmental Agreement for Temporary Resurfacing Access between Hall County, Georgia and the Hall County Board of Education and establish a project budget in the amount of \$65,000.00.

#### History:

This access road has been in need of resurfacing/paving. This road is used by many Hall County residents to access governmental services, including the compactor site and library. Additionally, this road provides the main ingress/egress for the Hall County School System Bus Shop.

#### Facts and Issues:

#### Options:

Hall County BOE agrees to allow Hall County and its employees and contractors temporary access to certain of its real property located at 2915 Atlanta Highway, Gainesville, Georgia 30507 for the sole purpose of completing the road resurfacing/paving. This section of road is located on Hall County BOE property; however, this road allows for public access to the Blackshear Place Library and Blackshear Place Compactor Site which are both Hall County, Georgia properties. The Hall County BOE will provide such access for sixty days beginning on the day that this Agreement is fully executed by both parties. The portion of the road as to which access will be granted by the Hall County BOE is the portion of the access road identified as "road project" in the aerial photograph attached hereto as Exhibit A, and immediately adjacent to the property marked as "HCSS Bus Shop." Please see the attached IGA for additional details. Additionally, a project budget of \$65,000.00 needs to be established in SPLOST VIII - Road Resurfacing.
