Facts and Issues:		Options:			

Hall County engaged in a Wage and Compensation Study with Carl Vinson on September 12, 2019. Due to the COVID pandemic, the study was suspended until further notice. In 2021, the project was restarted with the same purpose and objectives. The Wage and Compensation Study appropriately places the County in a competitive compensation structure to employ high quality individuals and retain its existing employees along with their knowledge and experience. This resolution will also provide a three (3) percent cost-of-living-adjustment (COLA) for all eligible employees. Both the Wage and Compensation Study and three (3%) COLA will be effective January 1, 2023 and paid on the January 20, 2023 pay date.
