### **Executive Summary:**

Purpose of Request:

The purpose of this request is to receive Board approval to purchase all of the furniture needed to outfit the Pre-Trial Accountability Services (PAS) Building on Jesse Jewell Parkway for use by Courts system staff beginning July 1, 2023.

#### Facts and Issues:

All of this furniture is on state contract and is the same furniture purchased for the 4th floor government center renovation. This is another step in standardizing purchases, branding, etc. countywide, an initiative tied closely to Hall County's Strategic Plan. Additionally, although furniture is not needed until mid-year, a purchase is required at this time due to continued long lead times for this industry.
