





- ALL FOOTINGS SHALL BEAR ON NATURAL UNDISTURBED SOIL HAVING A MINIMUN SAFE BEARING CAPACITY OF 2,000 PSF, OR ENGINEERED CONTROLLED COMPACTED FILL AS REQUIRED HAVING ALLOWABLE BEARING CAPACITY OF 2,000 PSF. THERE WAS NO GEOTECHNICAL REPORT DURING THE DESIGN OF THIS BUILDING. ### METAL DECKS

- ALL METAL DECKING SHALL BE DESIGNED, FABRICATED AND ERECTED IN ACCORDANCE WITH THE LATEST EDITION OF THE "SPECIFICATION OF THE STEEL DECK INSTITUTE".
- METAL DECK SHALL BE AS FOLLOWS:
  - NON-COMPOSITE FLOOR DECK SHALL BE SIMILAR TO 1" 22 GAUGE STEEL FORM DECK EQUIVALENT TO VULCRAFT 1.0C22 CSV CONFORM DECK SHALL HAVE THE FOLLOWING MINIMUM PROPERTIES PER FOOT

- ALL METAL DECKS HAVE BEEN DESIGNED TO BE CONTINOUS OVER 2 SPANS MINIMUM, AND SHALL BEAR AT LEAST 2" ON STEEL SUPPORTS.
- DECK SHALL BE WELDED TO SUPPORTING STEEL AT ENDS OF UNITS AND ALL INTERMEDIATE SUPPORTS IN ACCORDANCE WITH MANUFACTURER'S RECOMMENDATIONS (UNLESS NOTED OTHERWISE ON PLAN).
- 6. STANDARD CLOSURE SHALL BE PROVIDED AS REQUIRED.
- SHOP DRAWINGS SHALL INDICATE ALL INFORMATION NECESSARY FOR A COMPLETE FABRICATION AND ERECTION OF THE METAL

- PROVIDE STEEL LEDGER ANGLE 2 1/2" x 2 1/2" x 1/4" AT STEEL COLUMNS AS REQUIRED FOR SUPPORT OF METAL DECKING.

### LIGHT GAUGE METAL STUDS

- THE ENGINEERING OF ALL STRUCTURAL LIGHT GAUGE METAL STUD WALL INCLUDING THEIR CONNECTIONS AND LINTELS SHALL BE THE RESPONSIBILITY OF THE CONTRACTOR.
- ALL LIGHT GAGE METAL INFORMATION SHOWN ON THE DRAWINGS ARE BASED ON DIETRICH INDUSTRIES, INC. PRODUCTS.
- ALL LIGHT GAGE STUDS MUST BE MANUFACTURED WITH CORROSION RESISTANT STEEL OR GALVANIZED IN ACCORDANCE WITH ASTM A525.
- 4. ALL MEMBERS SHALL MEET THE FOLLOWING REQUIREMENTS:

ALL 54 mil & HEAVIER MEMBERS — ASTM A446 GRADE D (50 KSI MIN.) ALL 43 mil & LIGHTER MEMBERS — ASTM A446 GRADE A (33 KSI MIN.)

- ALL LOAD BEARING STUDS MUST BE SEATED TIGHT, WITHIN 1/16" AGAINST TRACK, WEB. ALSO, STUD MUST BE SCREW ATTACHED OR WELDED TO EACH TRACK LEG.
- ERECT FRAMING AND PANELS PLUMB, LEVEL AND SQUARE IN STRICT ACCORDANCE WITH THE APPROVED SHOP DRAWINGS.
- HANDLING AND LIFTING OF PREFABRICATED PANELS SHALL BE DONE IN A MANNER AS TO NOT CAUSE DISTORTION IN ANY MEMBER.
- 8. TRACK SHALL BE SECURELY ANCHORED TO THE SUPPORTING STRUCTURE AS SHOWN ON THE ERECTION DRAWINGS. CONCRETE ANCHORS SHALL BE INSTALLED AFTER FULL COMPRESSIVE STRENGTH HAS BEEN ACHIEVED.
- 9. ALL TRACK BUTT JOINTS, ABUTTING PIECES OF TRACK SHALL BE SECURELY ANCHORED TO A COMMON STRUCTURAL ELEMENT, OR THEY SHALL BE BUTT-WELDED OR SPLICED TOGETHER.
- STUDS SHALL BE PLUMBED, ALIGNED AND SECURELY ATTACHED TO THE FLANGE OR WEBS OF BOTH UPPER AND LOWER TRACKS.
- JACK STUDS OR CRIPPLES SHALL BE INSTALLED BELOW WINDOW SILLS, ABOVE WINDOW AND DOOR HEADS, AT FREE STANDING STAIR RAILS AND ELSEWHERE TO FURNISH SUPPORT AND SHALL BE SECURELY ATTACHED TO SUPPORTING MEMBERS.
- 12. FRAMED OPENINGS SHALL INCLUDE HEADERS AND SUPPORTING STUDS AS SHOWN ON SHOP
- 13. TEMPORARY BRACING SHALL BE PROVIDED UNTIL ERECTION IS COMPLETED.
- 14. PROVIDE HORIZONTAL BRIDGING FOR ALL STUDS AT 48 INCH. ON CENTER, OR PER MANUFACTURER'S RECOMMENDATION.

**RIGID FRAME ELEVATION: FRAME LINE 6** 


