Approve the purchase of Asphalt Repair Paving Services at four (4) Fire Stations for Fire Rescue to Allied Paving Contractors of Pendergrass, GA, in the amount of \$227,148.75 for the four (4) fire stations notated below: Fire Station # 10, Asphalt Patching, Overlay, Edging, Crack Seal & Restriping, \$52,045.00 Fire Station # 11, Asphalt Patching, Overlay, Edging, Crack Seal & Restriping, \$53,691.25 Fire Station # 12, Asphalt Patching, Overlay, Edging, Crack Seal & Restriping, \$55,450.00.

Purpose of Request:

To provide much needed asphalt repair work to driveways and parking lots at the four (4) fire stations mentioned.

Facts and Issues:

Pittman Construction, the other Demand Service On-Call contract holder for RFQ/P #42-002 Demand Services for Resurfacing, Paving and Full Depth Reclamation, declined to bid, citing that driveways and parking lots are not their speciality.

History:

Allied Paving Contractors of Pendergrass, GA is an awarded On-Call asphalt paving contract holder, in good standing with the County, and was awarded from the competitive bid RFQ/P #42-002 Demand Services for Resurfacing, Paving and Full Depth Reclamation, approved by the Board on Agenda Item #445 /2021 on 2021-08-26.
