The renewal of the Excess Workers Compensation with Midwest Employers Casualty Company will cost \$363,347, which is an 8.4% increase, and includes the Risk Management fees at \$25,000 and the claims TPA fees at \$60,000. There was no change in fees for the Risk Management Services and claims TPA.
