## Purpose of Request:

Approve the application of the U.S. Bureau of Justice Assistance's State criminal Alien Assistance Program (SCAAP) for the Hall County Sheriff's Office to reimburse housing of alien prisoners and personnel in the amount of \$126,711.00, and if awarded, appoint the Grants Manager as the Program Designee and authorize the Chairman to execute all related application and award documents. #### **Facts and Issues:**

This is federal funding from the U. S. Bureau of Justice Assistance (BJA) which makes payments to units of local governments that incur certain types of costs due to incarceration of undocumented criminal aliens during a specific 12 month reporting period (July 1, 2020 through June 30, 2021).

Hall County has received SCAAP funding since 2004. The Board of Commissioners approved the last application on April 14, 2022 agenda number 129 item number 132/2022.
