#### **Purpose of Request:**

This project is to update the audio system at the Ag Center. The intention is to showcase the facility as the premier location for outdoor events in North Georgia.

#### **Facts and Issues:**

The original system is in need of upgrading. The facility is large and includes many buildings and arenas. By upgrading, there would be communication from the tower, to the barn, activity hall and arenas. An upgraded system would be integral in attracting major events to the facility. Concerts, rodeos, dog agility competitions, large company picnics / meetings, dog / cat adoption events, church meetings, and a variety of other events are possible with these improvements.

The current system is likely the original system that was installed when the facility was built. The new PA System was competively bid on IFB# 040-43 and dB Intergrations would be the selected bidder.
