Approve the RFQ-P #43-043 for Augmented Staffing Services for CDL Drivers for the Landfill, Resource Recovery and Solid Waste Divisions, to E.D. Staffing of Marietta, GA for an estimated annual cost of \$626,080.00.

Purpose of Request:

Hall County Landfill and Solid Waste Division is seeking staffing services to provide seven (7) CDL drivers to augment the current staffing needs. The CDL drivers will be hauling trash/recycling containers via roll-off treuks to and from the compactor sites, landfill and the recycling Center.

History:

The Solid Waste Division currently has 11 openings for CDL drivers.

Facts and Issues:

For comparision purposes, the county would be spending \$654,973.48 for 7 fulltime CDL drivers (includes salary and benefits) per year. This amount is already included in the current budget. This proposal, if approved, would result in a direct savings of \$28,893.48 per year and other indirect savings through any workers comp related incidents.
