I live inside Friendship Farms Subdivision which is located across the creek from the property at 3515 Friendship Rd.

3515 Friendship Rd is located between a 127 residential homes subdivision on the left, 2 residential homes within feet of this property to the right and then another subdivision on the other side of them. The noise and traffic because of this property at 3515 Friendship Rd would effect nearly 200 homes surrounding it. We have been informed that the owner, Matthew Miller, plans to hold different types of venues on this property including the Trail of Terror from September until November. This particular venue runs starting at dark until at least 2:00 am with loud music, people screaming and people being chased with a chainsaw. The old location for Trail of Terror was on a property next to a church which was 1/2 a mile away and the noise could still be heard from our subdivision but no one lived next to it.

Friendship Rd is 6 lanes separated by a concrete divider. The property at 3515 Friendship Rd has no opening in front of it. If traffic comes from Hog Mountain they would have to make a U-turn in front of Friendship Farm subdivision, go across 3 lanes, and then slow down to pull into 3515's parking lot. Once the parking lot is full the traffic would be backed up. This would add more unwanted traffic, accidents, wait time for homeowners to get home and unwanted noise.

Thank you for taking our concerns into consideration. I do not agree with building a parking lot, allowing venues of any kind on this property nor moving of the building.

The property in question of the variance request would have a direct impact to the current quality of life of the residents of the Friendship Farms subdivision specifically in traffic on Friendship Road, in noise going into the late hours of the night and the environmental associated with having an event type venue next door.

In 2018, Matt Miller was granted a "conditional use" permit for a 37.5-acre site at 3760 Friendship Circle for the agri-entertainment venue.

Mr Miller wants to move the venue from a 37.5 acre tract to a 13 acre tract. The new site is bordered by 123 homes in Friendship Farms, 24 homes on Maple Valley Ct. and other residential lots. There are currently no other venues of this size surrounded by residential communities in the Friendship Road corridor.

I do not support this variance due to several concerns and questions.

- 1. Traffic problems related to the physical layout of the lot and the intersection [not just an increase in traffic] will negatively impact the Friendship Farm subdivision. Friendship Rd is limited access and venue traffic from I985 direction will require U Turns at the subdivision entrance. In addition, the property is located at the bottom of 2 hills and there is currently no turn in lane or way for traffic to get up to speed when leaving property.
- Damages in the form of noise and visual intrusions on peace and privacy, including Friendship Farm pool and playground area, would occur in direct conflict with Ordinance section 8.80
  - a. Loud music, screams, chainsaws, motorbikes can be heard from the current location 1.1 miles away. We expect the new location noise will be at a level detrimental to our enjoyment of our property and subdivision amenities.
  - b. Current venue location lists hours of operation until midnight on weekends.
  - c. Open flames are used in the Trail of Terror and proposed property is heavily wooded unlike the current location.
  - d. No fencing to protect surrounding residential areas from intrusion.
- 3. What is the impact of stormwater run off to the creek if large portions of property are converted to gravel parking or landscape is significantly changed to accommodate venue?
- 4. This is a septic property which has a large flood plain and is bordered by a creek. How will the change to an event venue impact the environment?
