- 3. The development shall follow all Hall County Development Review processes and stormwater requirements as established by the Official Code of Hall County and any other applicable agency.
- 4. The applicant shall obtain a commercial driveway permit, for construction of the entrance at SR 60, from the Georgia Department of Transportation prior to issuance of a CO for buildings on lots 2 & 3. The applicant shall obtain a commercial driveway permit, for construction of the entrance at SR 136, from the Georgia Department of Transportation prior to issuance of the final CO for the last building on the campus.
- 5. The zoning conditions shall be placed on any plat or site plan prepared for the property.
- 6. Prior to issuance of a land disturbance permit for the individual parcels, a landscape and lighting plan shall be submitted to the Planning Director for approval.
- Signage shall be as amended on 2-2-2023 and approved on 2-6-2023 and shall require building permits. Minor changes can be approved by the Planning Director provided there is no increase in the square footage of the sign types.
- 8. Allow basic architectural theme and materials as shown on attached renderings including phenolic siding.
- 9. TPO roof systems shall be allowed as an approved roofing material.
