While the residents of Lanier Village Estates welcome an expansion of medical facilities right across the street from us, our biggest concern is the effect the medical park will have on traffic through the intersection at our entrance. The traffic produced by this expansion will be in addition to the traffic produced from the 225 apartments under construction at Treesort, the 185 townhomes starting construction behind the CVS, and the 202 residential units recently approved on Price Road right next to all this other construction. That construction alone will likely produce an addition 5,000 trips per day through the Price Road/Thompson Bridge intersection.

We are hopeful that NGHS and the developers for the previously mentioned projects might coordinate with the GDOT to implement traffic flow and lane improvements for that intersection, including dedicated left turn lanes for northbound and southbound traffic for Thompson Bridge. 

1. There is no mention of how noise is to be controlled during the construction / building process as it will be a nuisance to surrounding residents. How will noise be handled?

2. (Agenda Page 193) (NGHS 2 of 68) Recommended conditions Item# 6 - Landscape and lighting plan shall be submitted prior to land disturbance permit being issued. What are the buffers between residents and proposed site? The only thing mentioned is a required 25ft buffer. Lighting as a problem for surrounding residents as most commercial lighting is at heights above normal landscape of residential outdoor security lights. How will barriers keep proposed lighting from being a disturbance to residential owners where properties join the proposed project?

3. (Agenda Page 207) (NGHS 16 of 68) Map – Comments regarding the required buffers on creek that feeds into other waterways mentions measuring from Location wrested vegetation instead of centerline of creek. (Public works letter Agenda page 258) (NGHS 66 & 67 of 68)

4. (Agenda Page 207) (NGHS 16 of 68) Storm water management pond – Public works letter (page 66 & 67 of 68 NGHS) states the site may need a stormwater management report. If no studies are provided, then the existing property owners will just be stuck with whatever impacts this project creates. If addressed up front, then accommodations can be considered.
