PEMB HORSE ARENA EXPANSION

***1 – 25' 4" Bay addition
2 – 25' Eave height
3 – 2" Insulation
4 – Chicken Wire
5 – Eight 8' x 8' x 2' Piers
6 – Paint frames white
7 - Sheet down to 12' at finished floor
8 - Eight quad wp receptacles on building columns
9 - One new 200-amp wp panel
10 – Intercept existing service and reuse to feed new panel
11 – Install in-ground J box on the existing service feeder
12 – Eight High-Bay LED lights tying to existing circuit

1. The contractor is amply protected with workmen's compensation, public liability and property damage insurance in connection with all work executive by it on the owner's premises and assumes all risks incident to the work done by it provided for in such insurance.
2. The contractor shall not be responsible for damage or delay resulting from acts of God, riots, civil commotions or disorders, delays or defaults by carriers or inherent defects in premises on which work is to be done; strikes, fires, accidents, storms, or other causes beyond its reasonable control.
3. If owner should default in the payment of any installment due under this contract and such default continues for a period of 30 days, contractor shall charge owner's account with a delinquency charge for the installment in default at the rate of 1% per month (12% per year). Also, if such payment so in default is referred to an attorney for collection, owner agrees to pay reasonable attorney's fees upon the collection of the amount due, plus all court costs.
4. This agreement shall become binding only when signed by the contractor's manager or upon the contractor's commencing actual work. Upon such acceptance or commencement, the agreement shall constitute the entire contract and be binding upon the parties hereto.
5. No verbal or other understanding other than indicated hereon shall be binding on the contractor.
6. The individual signing below personally guarantees payment of invoices and any other charges incurred under this account including legal or attorney's fees; attest financial responsibility, ability and willingness to pay our invoices
