## **QUIT-CLAIM DEED**

NOW THEREFORE, GRANTOR, for and in consideration of TEN (\$10.00) DOLLARS and other good and valuable considerations, in hand paid at and before the sealing and delivery of these presents, the receipt and sufficiency of which is hereby acknowledged, by these presents does hereby remise, convey and forever QUIT-CLAIM unto Grantee, its successors and assigns, any and all right, title and interest of Grantor in and to that certain real property, together with all improvements thereon, more particularly described as follows:
