<b>Purpose of Request:</b> To approve the resolution amending the Hall County Code so as to remove the appeal and variance provisions relating to the International Fire Code.		<b>History:</b> Hall County Code section 15.10.110 (B) currently provides for appeals and variances to the International Fire Code, which the County has adopted pursuant to Hall County Code section 15.10.020.	
<b>Facts and Issues:</b> O.C.G.A. Section 25-2-12 (a) (7) prohibits Hall County from allowing any waiver or variance which would excuse any building, structure, or proposed plans for buildings or structures from compliance with the state minimum fire safety standards as adopted in the rules and regulations promulgated by the State of Georgia. Therefore, this ordinance change would replace the appeal and variance provisions of Hall County Code section 15.10.110 (B) with a new subsection (B) which would allow appeals solely based upon a "mistake of fact" by the fire code official. Appeals would be heard by a Hearing Officer and the Hearing Officer's recommendation would be reviewed by the Board of Commissioners.		<b>Options:</b> Approve or deny the resolution.
