Purpose of Request:

Approve the award of IFB #046-43 for Security Fencing at Range to Hasbun Construction, LLC of Alpharetta, GA, in the amount of \$212,790.83.

Facts and Issues:

Fencing was constructed on the north and east property boundaries when the original range was built. The new range boundaries are being fenced in because the City of Gainesville 85 business park has encroached up to the property line of the new range.

This fencing project will secure the new range on all four (4) sides by adding fencing to the west and south property boundaries. The security gate will also be upgraded and replaced at the entry to the range. As the business park enters into tenant development stages, there is a significant safety concern regarding people having foot access to live fire areas as well as security concerns regarding theft and/or vandalism to the range.
