#### Purpose of Request:

Approve the award of Task Order #2023-030 Government Center Parking Lot Paving for Public Works & Utilities to Allied Paving Contractors, Inc. of Pendergrass, GA. The estimated cost is \$697,734.00.

#### History:

The drive has not been resurfaced since Hall County Government moved to the vacant building at 2875 Browns Bridge Road, Gainesville, GA, around September 2012. The parking lots and drive aisles must be resurfaced and the base repaired in various areas.

#### Facts and Issues:

The task order is a part of RFQ/P #43-014 Demand Services for Minor Resurfacing, Paving, and Sealcoating.

Public Works recommends Georgia Paving for this Task Order based on response time and the Vendor's availability schedule. Allied Paving is performing several jobs for Hall County, and Public Works would like to ensure the completion of them prior to the end of the current Fiscal Year. The work is anticipated to begin in late April/Early May, pending the roof contractor's demobilization schedule.

The scope of work includes milling, patching, paving, striping, and installing speed tables to replace existing speed bumps.
