Purpose of Request: Approve the ratification of the amended application and award of the 2023 Judicial Council American Rescue Plan Act Grant funding for the Northeastern Judicial Circuit to address case backlogs in the amount of \$512,000.00 and appoint the Grants Manager as the Program Designee and authorize the Chairman to execute all related application and award documents. No match is required. This brings the cumulative award for CY 2023 to \$2,500,000.00.		History: The Northeastern Judicial Circuit was awarded a total of \$1,988,000 for calendar year 2023, after Hall County approved the original application and submission in October 2022. Thereafter, in December 2022, the Judicial Council American Rescue Plan Act Funding (ARPA) Committee approved an additional category of eligible expense and raised the circuit cap from \$2M to \$2.5M. This new category was audio-visual equipment modernization projects in existing courtrooms, subject to certain rules and procedures.			
Facts and Issues:		Options:			

Governor Brian P. Kemp has allocated up to \$110 million in American Rescue Plan Act funds to address backlogs of court cases, prioritizing cases involving serious violent felonies. The Judicial Council of Georgia and its Administrative Office of the Courts will administer up to \$96 million in grants to authorized classes of court, prosecutors, and related agencies. The Ad Hoc Committee on American Rescue Plan Act Funding will exist from the date of October 28th, 2021 until December 31, 2024, unless otherwise extended. This item ratifies the amended application submitted by the Northeastern Judicial Circuit on April 14, 2023 seeking funds to be awarded in calendar year 2023.
