Purpose of Request: Approve the single source purchase of an Audio/Video Streaming System for Court Administration to S&L Integrated Systems, LLC of Thomasville, GA.		<b>History:</b> S&L Integrated has been a vendor of the County for several years and is in good standing. This proposal is approved for ARPA funds.			
Facts and Issues:		Options:			

This project will complete audio/visual upgrades and repair in six (6) courtrooms - three (3) Juvenile courtrooms, two (2) Magistrate courtrooms, and one (1) Probate courtroom. The scope of work includes a replacement of the current evidence presentation and digital recording systems, which are beginning to fail, and also includes the installation of new remote video technology. The pandemic unexpectedly ushered in a revolution in the way court proceedings are conducted, and many hearings now feature both live, in-person testimony and witnesses appearing via video. S&L Integrated previously installed similar systems in eight (8) Superior and State Court courtrooms, and this project will complete the transformation of all Hall County courtrooms into "hybrid" courtrooms. Grant funding has been awarded by the Administrative Office of the Courts' ARPA Committee for the entirety of this project.
