Department recommends the approval of the FY2024 contract renewal for the Property & Casualty Insurance program, which includes the Gallagher Bassett TPA services and Arthur J. Gallagher risk management fees, authorizing the Chairman to execute all related documents.

#### **Purpose of Request:**

The purpose of this request is to approve the annual contract for the Property & Casualty insurance program for FY2024. This insurance program consists of coverages for property, general liability, automobile, crime, terrorism & sabotage, excess liability, public officials liability, law enforcement, law enforcement off duty, cyber liability, aviation, AD&D, TPA fee, risk management fees, and actuarial.

#### Facts and Issues:

The total program cost for the FY2024 plan year is \$1,557,905.00 which is an increase of 17.1%. Some of the lines of business under the Property & Casualty umbrella experienced an increase in premiums due to the claims experience, and these lines include auto liability, property, law enforcement, crime, and terrorism/sabotage. The TPA fees increased by 39.8% due to claims experiences and additional systems access.
