**History:** Hall County has received Juvenile Justice Incentive Grant funding since 2014.

**Facts and Issues:** This funding will be used for Multi-Systemic Therapy (MST) and Family Functional Therapy (FFT) services to youth and families in Hall County. Families that identify a need for family counseling will be referred to MST for services by the Court. In the event a youth is exhibiting a need for individual counseling, he/she will be referred to FFT. All of the services will be conducted through a contractor and will be monitored.
