Approve change order under RFQ/P #41-001 Demand Services for Civil Engineering Services for Planning & Development to CPL Architects, Engineers, Landscape Architect & Surveyor, D.P.C. (P.C.) of Suwanee, GA.

## **Purpose of Request:**

Seek approval for one (1) Change Order to pay for services rendered by a third-party professional planning service by adding \$217,000.00 to PO #433118. The increase accommodates additional on-site staff to cover vacant positions. The additional staff is required to continue the current level of service for walk-in customers, processing permits, and conducting inspections.

#### Facts and Issues:

Funding will come from the salaries account within the department. This funding is available due to the vacant position savings. As required by the Hall County Purchasing Ordinance and based on the dollar value, the change orders must be approved by the Board of Commissioners.

#### History:

Currently, the Planning Department has four (4) vacant positions. Hall County has an existing Demand Services contract #41-001 for On-Call Civil Engineering Services and CPL is an awarded vendor. The Planning Department needs additional professional staffing services for a period of time, and CPL is in good standing within the County.
