- 9 & 10. Yelitza Ossa-OSAS Concrete – Applicant has corresponded with D1 Traffic Ops. D1 Traffic Ops responded “Looking at these addresses, it doesn’t appear that the existing driveways are commercial driveways, but residential drives. For commercial drives, we required radius drives with asphalt at least to the R/W line. We also have requirements on commercial driveway/side road spacing. Both of these requirements are safety driven.” Additionally, I would recommend a right turn lane for this driveway.
- 11 & 12. Over Under Storage, LLC, - GDOT coordination required. See attached comments.

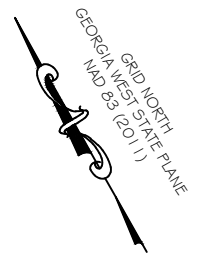
