I am writing to object to Zoning item #9 /#10 that requests to have agricultural property changed to light industrial so that it can be utilized as a commercial property for a concrete business and landscaping. We are within 500ft of this property located at Willow Brook community. Having commercial business in between a house and cemetary and the Willow Brook community is upsetting at the least. The impact it will have on allowing this to be changed does not bode well with property values, noise level throughout the day, increased traffic, delivery trucks of materials, and a change in the environment. There are animals such as owls, birds, deer etc., that frequent the area for food and places to live.

It will increase traffic which would have to make u-turns coming from 985 at the Maple Valley Dr., as well as u-turns at the Swansey Rd to go back to reach Spouts Spring. We already have enough noise and traffic from the Vulcan Quarry, 985 and Spouts Spring to reach their destinations. It can be difficult at times to turn left from Maple Valley so having others make u-turns complicates it even more. Some residents have had to turn right to make a u-turn at Swansey to get onto Friendship Rd, and head back towards Spouts Spring.
