Purpose of Request: Approval and authorization for the Chairman to execute an Intergovernmental Agreement with the Town of Braselton, City of Buford, Town of Clermont, City of Flowery Branch, City of Gainesville, City of Gillsville, City of Lula, City of Oakwood, and City of Rest Haven regarding a Transportation Special Purpose Local Option Sales and Use Tax (TSPLOST) and authorization for the Chairman to take any additional action necessary to effectuate the Agreement, subject to review and approval by the County Attorney.

History: The County and all of its Municipalities met to discuss a possible TSPLOST Intergovernmental Agreement on April 25, 2023. Following negotiations, the attached Intergovernmental Agreement has been proposed by all parties.

Facts and Issues: The proposed TSPLOST program will run for five years, and the rate of the tax will be one percent. The Intergovernmental Agreement sets forth the distribution formula for TSPLOST proceeds.

Options: In order for the TSPLOST Intergovernmental Agreement to become effective, Hall County voters must approve a referendum set for November 7, 2023.
