Facts and Issues:

Construct a gymnasium to be located at the Joseph F. Walters Boys & Girls Clubs of Lanier facility located on Memorial Drive,
Gainesville, Georgia. The gym will serve low income youths ages 518. The youth will benefit from health and education programing for afterschool and summer months activities. All costs above the grant amount and any match associated with the grant will be the responsibility of the Boys & Girls Clubs of Lanier. The Boys & Girls Clubs of Lanier are responsible for all costs associated with planning, designing, and supervising the construction of the gym.

Award is based upon the competively bid ITB #056-43 with Pencor, LLC being the lowest cost, responsible and responsive bidder. The contractor agrees to construct the new gymnasium for the Guaranteed Maximum Price of \$2,474,740.00.
