RENEWAL No. 002

Demand Services for Civil Engineering Services For On-Call Professional Planning Services

This Amendment Extension No. 002 by and between <u>CPL Team of Suwanee</u>, <u>Georgia</u>, and <u>Hall County, Georgia of Gainesville, Georgia</u> (together 'Parties'), to the original AGREEMENT executed 01/11/2022, and Amendment Extension No. 002, shall be effective as of ______. The County will issue a new Purchase Order to CPL Team for FY 2024 work, and all invoices for services rendered July 1, 2023 to June 30, 2024 must reference the new PO number.

WHEREAS, the Parties hereby mutually agree to renew the AGREEMENT for the period of one (1) calendar year after execution, and have the option, upon mutual agreement between the parties, of three (3) additional Extension options. Any new solicitations for services and subsequent contracts will supersede any Amendments thereto. The County may terminate this Amendment Extension No. 002 with sixty (60) days written notice. All payments will be made in arrears of services provided.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledge, the parties do hereby agree as follows:

SUCCESSORS AND ASSIGNS: This Amendment Extension No. 002 shall be binding upon and inure to the benefit of the successors and permitted assigns of the parties hereto.

ENTIRE AGREEMENT: Except as expressly modified by this Amendment Extension No. 002, the AGREEMENT shall be and remain in full force and effect in accordance with its terms and shall constitute the legal, valid, binding and enforceable obligations to the parties. This Amendment Extension No. 002 and the AGREEMENT and any subsequent amendments thereto, collectively, are the complete agreement of the parties and supersede any prior agreements or representations, whether oral or written, with respect hereto.
