Purpose of Request:

Approve the award of RFQ/P #43-027 Gainesville-Hall Metropolitan Transportation Plan: 2025 Update/Bicycle and Pedestrian Plan Update for the Gainesville-Hall Metropolitan Planning Organization (GHMPO) to RS&H, Inc. of Atlanta, GA, in the amount of \$398,500.00.

Facts and Issues:

The evaluation committee has chosen RS&H, Inc. as the constutant for this project. RS&H, Inc. was the highest rated vendor by a significant margin, and was rated second after including the pricing proposal. As the cost difference is minimal in the price proposal rankings, the committee decided RS&H, Inc. was still the best option for this project.

History:

Federal planning regulations require that the Gainesville-Hall Metropolitan Organization (GHMPO) update the region's long-range transportation plan. The Bicycle and Pedestrain master plan was adopted nearly a decage ago and needs to be updated to account for recent bicycle and pedestrian work being done. GHMPO is seeking a consultant to develop these two (2) updates into planning documents.
