As we are no planning to make any changes to the current the property We would like to ask for a Varience on a few of these points

# • 17.420.050.D.1. We request a variance on this point as the existing structure does not have an area adequate for planting shrubs. The entire area around the existing structure is either concrete or paved area.

• *Building perimeter walls.* Shrubs shall be planted within ten feet of the foundation of the primary structure along each building facade at the rate of at least 20 shrubs per 100 lineal feet of building facade except for sides or rear of building used for loading or service areas. Foundation plantings may be clustered to provide visual interest.

• 17.420.050.D.2.a. We request a variance on this as this is an existing structure and the entire area we are using is paved or has concrete.

• Along each street frontage there shall be a ten-foot wide landscape strip, continuous along the frontage except for perpendicular crossings for driveways and utilities. The landscape strip shall be planted with shade trees (six feet tall, two inches caliper, dbh, at time of planting, and not less than 35 feet tall at maturity) planted not less than 40 feet on center, and shrubbery forming an intermittent hedge not less than three feet in height designed to provide an adequate screen.

• 17.420.050.D.4.d. We request a variance on this point. We are not planning to install permanent displays. These are portable sheds that are available for immediate purchase and delivery, We keep the retail units in orderly lines (See Photos Provided).
