Purpose of Request:
Approve the purchase of one (1) Ford F-250 truck for Animal Services to Akins Ford Dodge Chrysler Jeep of Winder, GA, in the amount of \$53,100.00.

History:
Last fiscal year Animal Services purchased a dog box that will be mounted on this F-250. This will allow the truck to be utilized by an Animal Services Officer.

Facts and Issues:
Three (3) quotes were obtained from Akins Ford, Greene Ford Company, and Athens Ford.

Options:

Akins Ford provided the lowest price of \$53,100.00.

Current vehicle shortage has forced us to purchase vehicles from vendors that have availability. Staff compared this pricing to the Statewide Contract and the pricing listed is comparable to State Contract pricing. Staff recommends that due to a material disruption of goods and services and a lack of inventory, the purchase be considered through the County Ordinance Section 3.10.140(G).
