## Summary Analysis

The applicant is requesting a left side yard setback from 10 feet to 3 feet and a right side yard setback from 10 feet to 4 feet for the purpose of constructing a residential addition as well as bringing the existing residence into compliance with the setback requirements of the Vacation Cottage (V-C, <u>17.50</u>) zoning district.

The existing residence sits 7.32 feet from the left side property line and 4.70 feet from the right side property line. The proposed addition is to the front of the home that will result in new stairs located 3.22 feet from the left property line. The addition will not be any closer than the existing home currently is located to the right property line. Tax records indicates that the existing residence was built in 1964; this date is prior to the adoption of the Official Code of Hall County which occurred in August of 1978.

Two (2) **variances** related to setback requirements will be required if the site plan, as presented, is approved because the structure does not meet the side yard setback requirements.

Left side yard setback requirement of 10 feet as found in <u>Table 17.240.010</u> for the Vacation Cottage (V-C, <u>17.50</u>) district and right side yard setback requirement of 10 feet as found in <u>Table 17.240.010</u> for the Vacation Cottage (V-C, <u>17.50</u>) district.

## Zoning Analysis

The Planning Commission is hereby authorized to grant variances from the strict application of this Resolution upon proof by a preponderance of the evidence that 2.60.030.J provided the request meets the criteria set forth in 2.60.030.K.

- There are extraordinary and exceptional conditions pertaining to the particular lot in question because of its size, shape or topography (the hardship must relate to the physical character of the lot and not to a personal or economic hardship); The subject property is small in area and width, but the need for a variance has been created by the applicant's proposed additions to the home as opposed to the site conditions.
- 2. The application of the requirements of this <u>Title 17</u> to this particular piece of property would create an unusual hardship; The subject property can continue to be utilized as currently zoned, though the additions to the existing home would have to be modified to meet the 10 foot side yard setback and the existing home would remain encroaching into the side yard setbacks as it is currently located.
- 3. Such conditions are peculiar to the particular piece of property involved and are not common to other properties in the neighborhood; **The conditions requiring the variance are specific to this property.**
- 4. Such conditions are not the result of any actions of the property owner; **The applicants are** not responsible for the existing encroachment that occurred when the home was constructed in 1963, but the proposed improvements are designed by the applicant.
- 5. Relief, if granted, would not cause substantial detriment to the public good or impair the purposes and intent of <u>Title 17</u>; provided, however, that no variance may be granted for a use of land or building or structure that is prohibited by <u>Title 17</u> or for a conditional use which has been denied by the county planning commission. Any proposed land use would be limited by the use, bulk, and density regulations applied to the property based on the designated zoning district. The applicant is not proposing any uses not allowable within Vacation Cottage (V-C, <u>17.50</u>) district, and staff does not find that there will be any substantial detriment to the public good, if the variances are approved.
