The order bank for 2024 has not yet opened which will cause a major delay in purchasing the requested vehicles.

Since Brannen has trucks on order that will be available for Hall County Fire to pick up within 2 months, I recommend that we enter the required information in the system to proceed with the purchase of the vehicles from Brannen Motors.
