THIS INDENTURE ("Easement") is made as of the _____ day of ______, 2023 by and between the **BOARD OF COMMISSIONERS OF HALL COUNTY**, a political subdivision of the State of Georgia (together with its successors and assigns, "Grantor") and **CENTURY COMMUNITIES OF GEORGIA**, **LLC**, a Colorado limited liability company (together with their heirs, successors and assigns, "Grantee").

WITNESSETH:

<u>WHEREAS</u>, as set forth herein, Grantor is the owner of that certain real property located in Hall County, Georgia, being more particularly described on Exhibit "A" attached hereto and incorporated herein by reference (the "Grantor Property").

<u>WHEREAS</u> Grantor desires to grant and convey to Grantee certain easement rights over a portion of the Grantor Property being more particularly described below and on Exhibit "B" attached hereto and incorporated herein by reference (the "Easement Plat");

<u>NOW THEREFORE</u>, for and in consideration of the premises, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantor grants and conveys easements as set forth herein:

Article 1 Definitions

- 1.1 "Easement Area" shall mean and refer to, collectively that area shown and labeled as "10' Temporary Construction Easement 'A", "10' Temporary Construction Easement 'B" and that area shown and labeled as "Proposed 20' Utility Easement" on the Easement Plat attached hereto and incorporated herein as Exhibit "B".
- 1.2 "Easements" shall mean and refer to, collectively, the rights and interests conveyed to Grantee in the Easement Area as shown on the Easement Plat.
 - 1.3 "Grantor Property" shall have the meaning set forth in the recitals.
- 1.4 "Water/Sewer Facilities", "Utilities Facilities", or "Water, Sewer" shall mean and refer to collectively, the water, sewer, reuse water and wastewater infrastructure and equipment, manholes, sampling stations, fire hydrants, utility piping and equipment useful for such purposes and other water and sewer infrastructure, to be constructed within the Easement Area and operated and maintained by the Grantor upon expiration of the temporary easements granted herein.

Article 2 Grant of Easements

- 2.1 Grantor hereby grants and conveys unto the Grantee, its agents, employees and contractors (collectively, the "Grantee Agents"), a temporary non-exclusive access and construction easement (the "Temporary Construction and Access Easement") for the purpose of installing and constructing the Water/Sewer Facilities, and access thereto, in, on, over, under, upon, across, and through the Easement Area, together with the right of ingress and egress over the Grantor Property and other adjacent land of Grantor as may be reasonably necessary to accomplish the aforesaid purposes, but in no event shall the right of ingress and egress over the Grantor Property extend more than ten feet (10') beyond the Easement Area without express permission from Grantor. The Easements shall automatically terminate upon completion and final acceptance of the initial Water/Sewer Facilities by Grantor or one year after the date of conveyance of the Easements, whichever comes first (the "Easements Termination"). Any access over adjacent lands of the Grantor shall be coordinated by Grantee.
- 2.2 Upon the Easements Termination, Grantor shall become solely responsible for utilizing, testing, operating, maintaining, repairing, renewing, expanding and improving the Water/Sewer Facilities and Grantee shall have no Easements nor any remaining interest or rights to the Easement Area and Grantor Property.
- 2.3 The grant of the Easements herein includes the right at all times deemed necessary by Grantee for the Grantee Agents to exercise the rights herein granted to the Grantee, including, without limitation, to access said Easement Area, together with the Grantor Property and other adjacent land of Grantor, as necessary to obtain access to the Water/Sewer Facilities and for the purpose of exercising the rights herein granted and for no other uses or purposes; provided, however, that Grantor reserves the right to use the Easement Area in common with Grantee, and Grantor may cross and re-cross said Easement Area with persons, equipment, vehicles, fences, landscaping, operation of the fire department and similar uses that do not interfere with Grantee's rights hereunder. Any access over adjacent lands of the Grantor shall be coordinated by Grantee. The failure of the Grantee to exercise any of the rights herein granted shall not be construed as a waiver or abandonment of the right hereafter at any time, and from time-to-time to exercise any or all of the same. Any waiver shall be in writing and signed by the party granting such waiver.

- 2.4 Grantor warrants that no building, shed, mobile home, swimming pool, berms or other such permanent structures shall be erected or constructed within the Easement Area during the pendency of the Easements.
- 2.5 Limitation of Easement Rights. The Grantor does not convey fee simple title to the Easement Area, but merely grants the rights, privileges and Easements herein above set out.
- 2.7 Encumbrances. Grantor herein by these presents warrants there are no liens, mortgages, or other encumbrances affecting title to the Easement Area. Grantor warrants that it is legally qualified and entitled to grant the Easements herein granted with respect to the land described herein.
