CUSTOMER ASSISTANCE, PUBLIC INTERACTION, AND RULE AND REGULATION COMPLIANCE STATEMENT:

The primary role of <u>ALL</u> park staff members is first and foremost to courteously assist visitors and secondly to inform customers of the rules and regulations tactfully and respectfully to gain compliance. Unless otherwise specified, park staff are **NOT** rule and regulation enforcement personnel and shall not argue with, threaten, or badger uncooperative visitors. Park staff shall not attempt to detain, apprehend, or search any visitor or personal property. Park staff shall not use profanity in the presence of the public, project personnel, or contractors. Park staff shall notify and inform the Campgrounds Manager and a Corps Ranger of all problems encountered.

Park staff must be able to interpret and comply with Title 36, CFR, Chapter III, Part 327, "Rules and Regulations Governing Public Use of Corps of Engineers Water Resource Projects," as well as, park-specific policies, rules and requirements. Park staff shall report to a Corps Ranger and the Campgrounds Manager all accidents, violations of law, disturbances, and situations that could affect the health and/or safety of the visiting public. Serious or life-threatening incidents and/or emergencies shall be reported first to 911 and then to a Corps Ranger and Campgrounds Manager. In the event park staff is unable to contact a Corps Ranger, they shall contact local law enforcement officers, and then report the incident to a Corps Ranger as soon as possible. Corps Rangers will handle each case on its own merit, in accordance with Corps Visitor Assistance Regulations and training. Park staff shall not attempt to direct, manipulate undermine, oppose, impede or "second-guess" decisions made by Corps Rangers.

- Pick up litter throughout the park and shoreline.

- Assist guests with questions and concerns.
