The US Army Corps of Engineers is seeking assistance with the management of campgrounds on Lake Lanier. The Challenge Cost-Sharing Cooperative Management Agreement will allow Hall County Parks Department to perform operations and management activities, and to retain revenue generated at the included properties.

The County requested to enter into this Agreement via a letter signed by the Chairman on June 21, 2023.
