History: Hall County's Fire and Emergency Services has received the Trauma Grant since 2001.

Facts and Issues: The Georgia Trauma Care Network Commission (GTCNC) through the Subcommittee has approved a grant award opportunity using FY24 funding for EMS agencies for funds to be used for purchases of Trauma Related Equipment to equip ambulances. These funds are distributed on a reimbursement basis only. The grant amount is based on \$745.31 per ambulance. This amount is set by the Georgia Trauma Care Network Commission (GTCNC).
