A RESOLUTION TO AMEND THE CODE OF ORDINANCES OF HALL COUNTY
WITH REGARD TO TELECOMMUNICATIONS, TELECOMMUNICATION
ANTENNAS AND TOWERS, AND SMALL WIRELESS FACILITIES AND ANTENNAS

WHEREAS, Hall County has enacted ordinances entitled “Standards for Telecommunication Antennas and Towers” found in Chapter 17.410 and entitled “Standards for Small Wireless Facilities Placed in the County Right-of-Way” found in Chapter 17.412 of The Official Code of Hall County, Georgia; and

WHEREAS, the County has conducted a review and analysis of said Chapters 17.410 and 17.412 of its Official Code and determined that revisions to said Chapters are warranted; and

WHEREAS, the warranted changes include changes to said Chapters to clarify and modernize the County’s entire system of addressing Telecommunications, Telecommunication Antennas and Towers, and Small Wireless Facilities and Antennas issues, and to bring the County’s system of addressing those facilities and issues into line with systems in other jurisdictions that operate efficiently and which have withstood legal challenge; and

WHEREAS, the changes to said Chapters 17.410 and 17.412 of the Official Code of Hall County are attached hereto as Exhibit A; and

WHEREAS, the Board of Commissioners has determined that the revisions to Chapters 17.410 and 17.412 of The Official Code of Hall County, Georgia attached hereto as Exhibit A are in the best interest of the residents of Hall County, and will promote the health, safety, and general welfare of the residents and businesses in Hall County.

NOW, THEREFORE, the Board of Commissioners does hereby amend The Official Code of Hall County, Georgia as follows:

1.

Chapter 17.410 of The Official Code of Hall County is hereby amended by deleting Chapter 17.410 in its entirety and by inserting in lieu thereof a new Chapter 17.410 which provides exactly as described in Exhibit A attached hereto.

2.

Chapter 17.412 of The Official Code of Hall County is hereby amended by deleting Chapter 17.412 in its entirety and by inserting in lieu thereof a new Chapter 17.412 which provides exactly as described in Exhibit A attached hereto.

3.

The remaining provisions of The Official Code of Hall County shall remain as they were, unchanged by this amendment.
