Purpose of Request: Approve the sole source purchase of hardware, software and services, including Motorola CommandCentral Aware, Radio Location, and Radio Management for 911/Central Communications from Motorola Solutions, Inc. of Schaumburg, IL and establish a capital projects budget in the amount of \$480,983.00.		History: Motorola is a vendor in good standing with Hall County.		
Facts and Issues:		Options:		

Hall County 9-1-1/Central Communications is collaborating with the Hall County Sheriff's Office to obtain Radio Location and CommandCentral Aware to facilitate situational awareness. Radio Location Solutions with Enhanced Data will enable our dispatchers to follow radio subscriber units via their portable radios on a map. Hall County 9-1-1/Central Communications will utilize the CommandCentral Aware interface to view the additional features provided by Radio Location Solutions along with integrations to existing technology. This interface streamlines public safety workflows and viewpoints, enabling users to access and act on critical information.

Radio Management allows our Radio System Manager to remotely change radio aliases and install firmware updates without having to touch each radio in our fleet, increasing efficiency and adaptability of our system.
