Approve the award of RFQ/P #44-015 Georgia Safe Streets for All (SS4A) Action Plan for Public Works & Utilities to Alta Planning + Design, Inc. of Peachtree Corners, GA, in the amount of \$287,981.00.

Nine (9) responsive bids were submitted for RFQ/P #44-015. ALTA scored highest on qualifications and value. Hall County has used ALTA on previous projects.

The Safe Streets for All (SS4A) grant was awarded in January 2023.

This project is funded by the Federal Safe Streets and Roads for All Action Plan Grant with 20% Cash match coming from the Hall County Development Services Fund, the City of Gainesville, the City of Flowery Branch, and the City of Oakwood, based on 2020 population.

The percentage of required match contributions are:

Hall County 70.79%

City of Gainesville 21.86%

City of Flowery Branch 4.85%

City of Oakwood 2.49%

Hall County, GA in partnership with the Gainesville-Hall Metropolitan Planning Organization, and the cities of Flowery Branch, Gainesville, and Oakwood will develop an Action Plan with the goal of eliminating roadway fatalities and serious injuries by a certain percentage and date determined by the plan. Area representatives and a selected consultant/moderator will plan meetings and combine public input, data analysis, and statistics into a plan. A task force will be charged with supervising the implementation and monitoring.
