The New Easement shall be subject to those terms and conditions as described in the Original Easement.

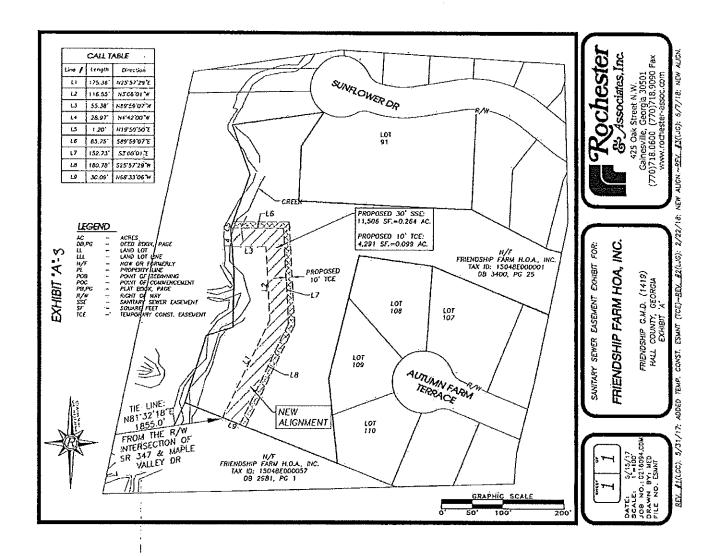
