### ACCESS, CONSTRUCTION, AND MAINTENANCE EASEMENT BOARD OF COMMISSIONERS HALL COUNTY, GEORGIA

Project Name: Friendship Road Corridor Sewer Extension

THIS EASEMENT CONVEYANCE made and executed August 28, 2019,

WITNESSETH that DAVID E. WILLIAMS and JOAN WILLIAMS as Co-Executors of the Estate of Edgar F. Williams, Jr. and the Estate of Helen Deaton Williams, and WILLIAMS FAMILY HOLDINGS, LLLP, hereinafter collectively referred to as GRANTOR, is the owner of a tract of land in Hall County adjacent to a project consisting of the placement and maintenance of sanitary sewer lines (the "Project"). The Project has been laid out by parties acting for the Hall County Board of Commissioners, Hall County, Georgia.

NOW, therefore, for and in consideration of one (\$1.00) dollar in hand paid, receipt of which is acknowledged, the GRANTOR does hereby grant and convey to HALL COUNTY, GEORGIA, hereinafter referred to as GRANTEE, an easement over, through, across and under the real property shown on Exhibit "A" and described on Exhibit "B", both of the Exhibits are attached hereto and made a part hereof.

### CONDITIONS/RESERVATIONS/SPECIAL PROVISIONS

The Grantee shall have the right of ingress and egress on the property of the GRANTOR for the purpose of constructing, installing, laying and maintaining said sanitary sewer line and shall exercise reasonable diligence in doing necessary work in connection herewith so as to avoid unnecessarily damaging the property of the GRANTOR.

A temporary Access and Construction Easement through the property of the GRANTOR
above described of Grantor as shown on the attached Easement Exhibit. The temporary
easement will allow for clearing of trees, brush and excavations within the easement

- necessary for installation of the sewer lines. The temporary easement will expire at the completion of project.
- 2) A perpetual Access and Maintenance Easement will extend a distance of fifteen (15) feet on either side of the completed sewer line on GRANTOR'S property. GRANTEE shall have the right to construct, maintain, operate, repair, replace, patrol, and remove sewer lines, manholes, gravel access driveways and appurtenances thereto, within the Access and Maintenance Easement area and through the above described property of the GRANTOR. GRANTEE shall have the right to clear and keep clear all trees, undergrowth and other obstructions from the easement herein granted. - 3) This Easement provides for access on Grantor's property by GRANTEE and/or GRANTEE'S employees, subcontractors and/or designated representatives, and includes all vehicles, equipment, tools, and materials necessary for completion of the project. All disturbed areas related to the project will be stabilized using Best Management Practices for control of soil erosion and sedimentation.

In exercising the rights herein granted, GRANTEE shall restore all easement and construction areas to as near as reasonably possible their original condition and contour, prior to said activities.

The terms and conditions hereof shall be binding upon and inure to the benefit of the heirs, executors, administrators, devisees, successors, trustees or assigns of the parties hereto.

The undersigned does not convey any land, but merely grants the rights, privileges, and easements herein before set out.

The above description of the project and special provisions were inserted before the execution hereof by the Grantor.




