Purpose of Request:

Approval and authorization for the Chairman to execute an Intergovernmental Agreement with the City of Buford for cooperative paving of a section of New Bethany Road, which are maintained by Hall County, subject to review and approval by the County Attorney. The estimated cost not to exceed is \$56,650.00.

History:

Facts and Issues:

Options:

Where possible and feasible, Hall County desires to minimize resurfacing work with multiple starting and ending sections of new asphalt on roads.

New Bethany Road runs intermittently through the incorporated area of the City of Buford and intermittently through unincorporated Hall County. This agreement minimizes the pavement being inconsistently resurfaced. A longer portion of New Bethany Road will still remain to be resurfaced and will be rated this upcoming winter to determine its inclusion in the Annual Resurfacing Program.

Buford agrees to resurface or repave a section of New Bethany Road which is approximately 3300 feet long and 18 to 20 feet wide. The section to be resurfaced runs from the intersection with South Waterworks Road to the northern boundary of the "Old Stringer Property" (which is located at 6191 New Bethany Road and identified as parcel number 07328 003002)

In consideration of the resurfacing work Hall County agrees to pay to Buford the total sum not to exceed of \$56,650.00.
