The Fire Truck will take approximately 48 months to build and ship. The price is based on the NPPGov (LOC) consortium Contract # PS20240 (ID # 1.07) by the lead public agency League of Oregon Cities (LOC) which is in effect until May 27, 2026. This price is only valid until January 29, 2024 after which it goes up 1.5%.
