ARTICLE #101 - INTRODUCTION

This Amendment for Emergency Additional Waste-Refuse Collection Services (hereinafter "Services") to Contract # 023-42 as entered into on December 14, 2023, and with a limited term from December 18, 2023 to June 30, 2024 is by and between; Hall County, Georgia, (hereinafter "County") located at 2875 Browns Bridge Rd, Gainesville, Georgia 30504, and Waste-Pro - of GA, Inc., located at 1405 Danielsville Road, Athens, GA 30601 (Hereinafter "Contractor"). Contractor is an entity that is legally registered and qualified, and holding any such licenses and certifications as may be required to render Services to do business in the State of Georgia. County and Contractor are known individually as a "Party" and collectively as the "Parties".

Whereas, the current Contract term is in effect from <u>July 1, 2023</u> – <u>June</u> 30, 2024, and

Whereas, the Parties do mutually desire to Amend the Contract which to document the provision of Additional Services for other good and valuable consideration by the Contractor to the County in exchange for payment as compensation, and

Whereas, this Amendment will become legally binding and executed upon signature by both parties, an

Whereas, any Exhibits, Attachments, and references are all incorporated herein by reference, and

NOW, THEREFORE and in consideration of the terms, conditions, mutual promises, covenants and agreements made as expressed and contained herein, or attached and incorporated and made a part hereof, and other good and valuable consideration, expressed by a valid offer and

acceptance, the receipt and sufficiency of which the parties hereby acknowledge, the Parties hereto agree as follows:

AMENDMENT

- A. Contractor agrees to provide the Services to the County as detailed in Exhibit A Solid Waste Hauling Schedule
- B. County hereby agrees as good and valuable compensation as outlined in Exhibit B Proposal, and is incorporated herein by reference.

SCOPE OF WORK

The County owns and operates twelve (12) compactor sites which have both trash and recycling roll-off containers, in addition to the County Recycling Center. The County averages 144 hauls per week. Anticipated hauls of Roll-Off Containers from <u>December 18, 2023</u> to <u>June 30, 2024</u> totals <u>4,032 hauls</u>.
