<b>Purpose of Request:</b> Approve the purchase of eight (8) new 2024 Ford Interceptors for the Sheriff's Office to Brannen Motor Company of Unadilla, GA, in the amount of \$381,600.00.		<b>History:</b> The County uses Clint Brannen Motors for vehicle purchases. They are in good standing with the County.	

Facts and Issues:

Options:

This is for the purchase of eight (8) 2024 Ford Interceptors for the Sheriff's Department per the attached quote, for a grand total of \$381,600.00.

The two (2) other quotes were provided by Allan Vigil and Cargurus.com Clint Brannen Motors was the lowest quote at \$47,700.00 each.

Current vehicle shortage has forced us to purchase vehicles from vendors that have availability. Staff compared this pricing to the Statewide Contract and the pricing listed is comparable to State Contract pricing. Staff recommends that due to a material disruption of goods and services and a lack of inventory, the purchase be considered through the County Ordinance Section 3.10.140(G).

Due to the vehicle shortage at this time, Brannen in Unadilla, GA has been meeting and sometimes beating the state contract pricing.
