#### **Purpose of Request:**

Approval and authorization for the Chairman to execute a Resolution authorizing the exercise of the power of eminent domain with regard to the Cagle Road Improvement Project, Parcels 28/29, Hall County tax parcel number 09094 000001 for public road purposes, and authorization for the Chairman to execute any and all additional documents necessary to effectuate the exercise of the power of eminent domain with regard to such parcel, subject to review and approval by the County Attorney.

#### **Facts and Issues:**

The Resolution authorizes acquisition of the property by negotiated settlement or, in the event that negations fail, condemnation.

#### History:

The County's land acquisition agent made multiple attempts to engage in good faith negotiations with the current property owner to arrive at just and adequate compensation for the portion of the property to be acquired. Counsel for the County discovered title issues, which call into question the fee interest of the current property owner. Counsel for the County recommends condemnation to clear title and acquire necessary property.
