



EXECUTIVE SUMMARY

The Leach Road development is a proposed residential development to be built on approximately 174 acres of undeveloped land in Hall County, GA. The development will be along the west side of Leach Road south of Willie Robinson Road and includes 307 single-family housing units. The development is split up into three pods and will have three new driveways, one for each pod, accessing Leach Road. The build-out of the development is planned for 2030. This study analyzed existing and future peak hour traffic operations and capacity analysis for the study intersections to determine if recommendations to the existing roadway network should be made to accommodate the new traffic and determine how the new driveways should be controlled.

This study analyzed the impacts the development's generated trips are expected to have on the surrounding roadway network and study intersections. The study intersections are listed below:

1. Leach Road at Willie Robinson Road
2. Leach Road at Chestatee Road
3. Willie Robinson Road at Ledan Extension
4. Willie Robinson Road at Cool Springs Road
5. Leach Road at Driveway A (*New Intersection*)
6. Leach Road at Driveway B (*New Intersection*)
7. Leach Road at Driveway C (*New Intersection*)

The ITE Trip Generation Manual, was referenced to estimate the trips generated by the land use to calculate the total gross trips expected to be generated from the residential development. The expected trips were added to the expected future volumes to analyze the delay and level of service at the study intersections in the build condition and compare to the existing and no-build conditions.

The existing study intersections are operating at an acceptable level of service in the existing and no-build conditions, prior to the addition of the development's traffic. The residential development is expected to have a nominal effect on the delay at the existing study intersections. The new driveways for the site are expected to operate at an acceptable level of service. The following is the recommended configuration and modifications to the driveway intersections:

Leach Road at Driveway A

- Driveway A should be two lanes, one entry and one exit lane.
- Driveway A should be full access and stop sign controlled.
- Provide a southbound right turn-lane on Leach Road.

Leach Road at Driveway B

- Driveway B should be two lanes, one entry and one exit lane.
- Driveway B should be full access and stop sign controlled.
- Provide a northbound left-turn lane on Leach Road.
- Provide a southbound right turn-lane on Leach Road.

Leach Road at Driveway C

- Driveway C should be two lanes, one entry and one exit lane.
- Driveway C should be full access and stop sign controlled.
- Provide a northbound left-turn lane on Leach Road.
- Provide a southbound right turn-lane on Leach Road.

No additional improvements to the existing roadway infrastructure are recommended.



INTRODUCTION




Figure 1 Location Map

A traffic impact study was conducted by Southeastern Engineering, Inc. for the proposed Leach Road development located in Hall County, GA. The development will be built on approximately 174 acres of undeveloped land, located along the west side of Leach Road. The development will include 307 dwelling units and have three new driveways accessing Leach Road. The build-out of the development is planned for 2030. An overall location map of the area near the site location is shown in **Figure 1**.

This study will identify the potential impacts of the proposed development traffic on the surrounding roadway network. The study includes the existing and future peak hour traffic operations and capacity analysis for the study intersections. As necessary, operational improvements will be identified and analyzed to mitigate the traffic impacts caused by the development. Based on the results of the analysis for the study intersections, recommendations will be made for intersection geometry and control method.

PROJECT DESCRIPTION

The Leach Road residential development will include 307 single-family homes and three new driveways along Leach Road. The developments are split into three pods of houses, for this study they are identified as Pods A-C with corresponding driveway names. There is a driveway proposed



for a clubhouse that will align with Driveway C, which will not be analyzed as a part of this study. This study analyzes traffic impact upon the full built-out of the proposed development, which is planned for 2030. The site plan is attached in **Appendix A**.

Study Network

The traffic study analyzes the current traffic operations for the intersections in the vicinity of the proposed development. Capacity analysis and level of service evaluations of the study intersections were conducted for the existing, future no-build, and build scenarios. The study intersections and their control type are listed below:

1. Leach Road at Willie Robinson Road – Minor-Street Stop-Control
2. Leach Road at Chestatee Road – Minor-Street Stop-Control
3. Willie Robinson Road at Ledan Extension – Minor-Street Stop-Control
4. Willie Robinson Road at Cool Springs Road – Minor-Street Stop-Control
5. Leach Road at Driveway A (*New Intersection*)
6. Leach Road at Driveway B (*New Intersection*)
7. Leach Road at Driveway C (*New Intersection*)

Roadway Conditions




Figure 2 Aerial of Study Area

The roadway network adjacent to the development was examined for the existing roadway characteristics. An aerial of the study area is shown in **Figure 2**.

Leach Road

Leach Road is a two-lane facility with a posted speed limit of 40 miles per hour. It is classified by GDOT as a local road. It connects to Willie Robinson Road in the north and Chestatee Road to the south. There is no curb and gutter or sidewalk present along the road in the study area.

Willie Robinson Road

Willie Robinson Road is a two-lane facility with a posted speed limit of 35 mph. It is classified by GDOT as a local road. It connects to Cool Springs Road to the west and Ledan Extension to the east. There is no curb and gutter or sidewalk present along the road in the study area.

Chestatee Road

Chestatee Road is a two-lane facility with a posted speed limit of 45 mph. It is classified by GDOT as a local road. It connects to Sardis Road to the east and Cool Springs to the west. There is no curb and gutter or sidewalk present along the road in the study area.

Ledan Extension

Ledan Extension is a two-lane facility with a posted speed limit of 45 miles per hour. It is classified by GDOT as a minor collector. It connects to SR 60 to the southeast and Cool Springs Road to the north. There is no curb and gutter or sidewalk present along the road in the study area.

Cool Springs Road

Cool Springs Road is a two-lane facility with a posted speed limit of 50 miles per hour. It is classified by GDOT as a minor collector. It connects to SR 136 / Price Road to the north and ends near Latham Creek in the south. There is no curb and gutter or sidewalk present along the road in the study area.

EXISTING TRAFFIC CONDITIONS

Existing traffic volumes at the study intersections were collected on Tuesday, August 15th, 2023. Peak hour turning movement counts were collected at the study intersections, and daily traffic volumes were collected on primary roadways near the development. Existing daily traffic volumes collected in the study area are summarized in **Table 1**, and the existing count data are attached in **Appendix B**. The existing AM and PM peak hour traffic volumes for the study area are shown in **Figure 3**.

Historical Growth Rate

A growth rate for the study area was calculated using annual volume statistics from GDOT’s Traffic Analysis & Data Application and Hall County census data. The growth rate calculated using GDOT’s traffic data is summarized in **Table 2**. Historical counts and calculations from the stations are attached in **Appendix C**.

Population projection data obtained from the Georgia Governor’s Office of Planning and Budget was used to calculate a growth rate for the study area. The Hall County data and estimated growth rate is shown in **Table 3**.

Census data from the U.S. Census Bureau was used to calculate a growth rate for Hall County. The growth rate estimated using the U.S. Census Bureau data is shown in **Table 4**. Growth rate data from all sources is shown in **Appendix C**.

The overall growth rate for this study was calculated averaging the source data, and an average, annual growth rate of 1.6% was calculated for this study to project future year (2030) traffic volumes.

Level of Service Methodology

Intersection capacity analyses were performed using the methodology outlined in the Highway Capacity Manual, 6th Edition (HCM). This methodology is the industry standard for the evaluation of intersection capacity and delay. To facilitate the analysis, computer software Synchro 11 was used. This software conforms to the methodology of the HCM.

An analysis of peak hour traffic conditions was performed to determine the level of service (LOS) at the study intersections. LOS for an intersection is based on vehicular delay at the intersection and is a typical measure of effectiveness used to evaluate intersection operations. The HCM provides



ranges of delay for each LOS definition, spanning from very minimal delays (LOS A) to high delays (LOS F). LOS F is considered unacceptable for most drivers.

For unsignalized intersections, where a stop sign controls side streets or minor streets, the criterion for evaluating traffic operations is the LOS for the controlled turning movements at the intersection. Methodology from the HCM to determine the delay and LOS for these turning movements is based on the following input data: intersection geometry, lane configuration, and turning movement volumes.

Table 5 below indicates the relationship between delay and LOS for unsignalized intersections.









Existing Level of Service

The level of service for the existing conditions was determined using Synchro 11, which follows the HCM methodology. The existing geometric configurations and intersection controls were used for the analysis. The peak hours identified for analysis were 0700-0800 for the AM peak hour and 1700-1800 for the PM Peak hour.

All existing intersections operate acceptably in the existing conditions (LOS A-B). **Table 6** summarizes the results of the intersection capacity analysis for the existing conditions. Detailed Synchro reports are attached in **Appendix D**.

FUTURE CONDITIONS – WITHOUT THE PROPOSED DEVELOPMENT (NO - BUILD)

The impact of the proposed development on the roadway network was analyzed and evaluated in the future year (2030) without the proposed development (No-Build) to compare the future conditions with the proposed fully constructed development (Build).

Future No - Build Traffic Volumes









The future background traffic volumes (2030) were calculated by applying the annual exponential growth rate over seven years to the existing background traffic volumes (2023). Future background traffic volumes are shown in **Figure 4**.

Future No - Build Level of Service

The future 2030 background traffic volumes were used to analyze the future no-build level of service for the study intersections. The same LOS methodology discussed previously was applied to the 2030 background traffic to determine operations at the study intersection. **Table 7** summarizes the results of the intersection capacity analysis for the future no-build year. The study intersections continue to operate acceptably in the no-build scenario, LOS A-B. Detailed Synchro reports are attached in **Appendix D**.

PROPOSED DEVELOPMENT

The development will include 307 single-family homes and three new driveways along Leach Road. The build-out of the development is planned for 2030. The development will be split into three pods, Pods A-C from north to south with corresponding driveway names.

Trip Generation

The number of trips expected to be generated from the development were estimated based on the method defined in the Institute of Transportation Engineers (ITE) Trip Generation Manual, 11th Edition. Due to land use of the development no pass-by or internal capture trip reductions are expected. The trip generation for the proposed development is summarized in **Table 8**. The trip generation report is attached in **Appendix E**.









The generated trips were divided by pod to reflect the number of homes accessed by each driveway. The pods and driveways are labeled in the site plan attached in **Appendix A**. The trip generation by pod is shown in **Table 9**.

Trip Distribution and Assignment

The trips expected to be generated from the proposed development were distributed on the roadway network in the study area. The proposed distribution is based on historical counts and observed traffic patterns in the area. Generated trips assigned to the adjacent street network are shown in **Figure 5**.

Auxiliary Lane Analysis

The need for auxiliary lanes on Leach Road were evaluated at the new driveways based on the guidelines from GDOT’s *Regulations for Driveway and Encroachment Control*. Auxiliary lanes are used on approaches to intersections when the projected turning traffic volumes exceed minimum levels. If the left turning volume meets or exceeds volume thresholds defined in the GDOT manual, a left-turn lane is recommended at a study intersection. Based on the GDOT manual a left-turn lane is recommended at an intersection if the threshold values as shown in **Table 10** are met or exceeded.

Per the GDOT manual, a right-turn lane is warranted at an intersection approach if the daily right-turn volume meets or exceeds the values as shown in **Table 11**.

Leach Road is a two-lane route, with an average daily traffic volume of approximately 496 vehicles per day (vpd) and has a posted speed limit of 40 miles per hour. Based on these characteristics the threshold for a left turn lane is set at 250 LTV per day, and the threshold for a right-turn lane is set at 150 RTV per day.

Based on the expected trip distribution, all auxiliary thresholds meet except for the left-turn threshold at Driveway A. The results of the analysis are shown in **Table 12**.

FUTURE CONDITIONS- WITH THE PROPOSED DEVELOPMENT (BUILD)

To assess the traffic impact of the development, the site-generated trips were added to the future background traffic, and the combined volumes were analyzed.

Future Build Traffic Volumes

This future build analysis was conducted to determine any impacts to the study intersections resulting from traffic from the full build-out of the proposed development. The site-generated trips assigned to the adjacent roadway network were added to the background traffic volumes and are presented in **Figure 6**.

Future Build Level of Service

The level of service criteria discussed in the prior sections was applied to the study intersections to determine the impacts of 2030 background traffic volumes plus total site-generated volumes. All study intersections were analyzed with the existing geometry and intersection controls. The development driveways were modelled as full access stop sign controlled approaches, with one entry and one exit lane and turn lanes on Leach Road recommended as previously identified. The results of the intersection capacity analysis for the future year with the development are summarized in **Table 13**. Detailed Synchro reports are attached in **Appendix D**.










Table 14 shows a comparison of the delays in all scenarios for the study intersections. The proposed development has a nominal effect on the delays at the study intersections. The development driveways are expected to operate at an acceptable level of service upon completion of the development.

Conclusion and Recommendations

The Leach Road development is a proposed residential development to be built on approximately 174 acres of undeveloped land in Hall County, GA. The development will be along the west side of Leach Road south of Willie Robinson Road, and includes 307 single-family housing units split up into three pods, and will have three new driveways accessing Leach Road. The build-out of the development is planned for 2030. This study analyzed the impact of the development on the study intersections to determine feasible intersection controls to accommodate the development traffic along with growth of the Hall County.

Under existing conditions, all study intersections are operating at an acceptable level of service in the existing and no-build scenarios. The development will have a nominal effect on the delays at the existing intersections. The intersections will continue to operate at acceptable levels of service.

The new driveways for the site are expected to operate at an acceptable level of service upon completion of the development. Right-turn lanes should be provided on Leach Road at all of the driveways and left-turn lane are recommended at Driveways B and C.

The recommended driveway configuration and control types for the development driveways are listed below:

Leach Road at Driveway A

- Driveway A should be two lanes, one entry and one exit lane.
- Driveway A should be full access and stop sign controlled.
- Provide a southbound right turn-lane on Leach Road.

Leach Road at Driveway B

- Driveway B should be two lanes, one entry and one exit lane.
- Driveway B should be full access and stop sign controlled.
- Provide a northbound left-turn lane on Leach Road.
- Provide a southbound right turn-lane on Leach Road.

Leach Road at Driveway C

- Driveway C should be two lanes, one entry and one exit lane.
- Driveway C should be full access and stop sign controlled.
- Provide a northbound left-turn lane on Leach Road.
- Provide a southbound right turn-lane on Leach Road.

No additional improvements to the existing roadway infrastructure are recommended.






