Purpose of Request:		History:			

Discussions began in 2017 regarding moving away from CJIS (in-house case management/financial receipting program)

Due to this upcoming change, Clerk made decision to go ahead with changing the Real Estate receipting program separately from the case management system, as the proposed vendor did not have a Real Estate option.

Agreement with Kofile/County Fusion for Real Estate indexing/financial receipting was signed by Clerk on October 8, 2019. (Agreement stated valid for 12 months from date of go-live, then four 1-year auto-renewals. Exp. 8.3.24)

"Go Live" date for Kofile/County Fusion was August 3, 2020.

"GovOS, Inc." press release February 1, 2021. New Company under umbrella of Kofile.

Contract with ICON for case management/financial receipting software program signed September 28, 2021.

Request by Clerk's Office to add Real Estate conversion and support to ICON contract presented at work session June 2, 2022.

Approved ICON Real Estate contract addendum signed June 9, 2022.

"Go Live" date for ICON case management/financial receipting was November 14, 2022

GovOS ratification of agreement dated August 3, 2023. Confirms details of agreement from October of 2019. Clarifies "go-live" date. Clarifies that Kofile was predecessor of GovOS.

As of January 17, 2024, Clerk's Office has not started formal process of converting from County Fusion to ICON/Catalyst.

Kofile/County Fusion Budget Information:

FY24 (July 2023-June 2024)

Clerk's Office requested \$129,650 for account 100-280-52100 (General Fundstechnical and professional services). Included in this total was a one-time amount of \$47,600 which was requested for a conversion from Kofile/County Fusion to Catalyst/ICON. This conversion cost was approved on 6.2.22. As of 1.17.24 this conversion has not taken place. Additionally, \$26,400 of the original request has not been used either, as this is for ICON monthly maintenance fees.

The Real Estate division records all land transactions for Hall County. The records begin in the year 1819 and go through the current year. Document can be searched in the indexes by year and name. Land plats are recorded in this division and are indexed by years under the name of the person that hired the surveyor.

Uniform Commercial Code Records

Uniform Commercial Code records can be found and filed here and electronically filed through the Georgia Superior Court Clerks Cooperative Authority. Uniform Commercial Codes are liens placed on personal property used as collateral, such as liens on boats, TVs, computers, and items in a business inventory.

General Execution Dockets

General Execution Dockets are found in this division. These dockets contain liens placed against an individual including hospital liens, federal and Georgia income tax liens, pending suits, Preliminary Notice of Lien Rights, and Materialman's Liens.
